## INTRODUCTION

The Warren County Combined Health District is devoted to the Prevention of disease and injury, the Promotion of wellness and healthy living, and the Protection of the public from communicable disease and health threats.

The Warren County Combined Health District touches the lives of every Warren County resident by:

- Inspecting restaurants and groceries to assure food is safe and to educate operators on food safety.
- Protecting the community from the spread of infectious and communicable diseases.
- Assuring safe private water wells and home sewage treatment systems.
- Providing immunizations for all ages to prevent illness.
- Inspecting public pools, schools, camps and manufactured home parks.
- Making home visits to address concerns about family health and public health nuisances.
- Providing certified birth and death certificates.

In 2012, WCCHD began the process of implementing an Electronic Medical Record system. We evaluated a number of EMR to determine which would best serve the needs of our clients. Ultimately we selected e-MD. We have begun the build out of our network and starting training. The system will be fully implemented in the spring of 2013.

We also began working with the Ohio Department of Health as they develop a statewide environmental health inspection program. This program will allow us to do more inspections on our computers. Ultimately it will allow anyone to search a state database for inspection results. The state plans to roll this out in the summer of 2013.

## CLINICAL SERVICES

The Warren County Combined Health District's clinical services continue to change and expand along with the growing changes in our community. The unemployment rate of Warren County definitely impacts the number of clients we are seeing yearly.

The **Prenatal Clinic** offers total obstetrical care for clients at the Lebanon office with delivery at Bethesda North Hospital of TriHealth. The staff consists of OB/GYN physicians (from Bethesda North), R.N.s, a licensed dietician, case worker, and a secretary. Early and consistent prenatal care is encouraged to help ensure the health and well being of both mother and child. Clients who start prenatal care early and keep all their appointments receive a free car seat (with car seat education, if needed). In addition, the prenatal staff has placed greater emphasis on counseling and referral of clients with specific social problems and on counseling clients on daily health, nutrition, and smoking patterns. Caseworkers assist clients in applying for Medicaid when applicable.

The **Child Health Clinic** in both the Lebanon and Franklin offices provides comprehensive routine exams, school and work physicals and acute care for children from birth to 21 years of age. These exams include screenings and lab work if necessary. The staff consists of a physician, R.N.s, a secretary, case worker, and licensed dietician. Because early identification of problems can decrease the likelihood of life long disabilities, referrals to other agencies, such as Help Me Grow, BCMH, etc., are made if necessary. Also, caseworkers assist clients in applying for Medicaid, when applicable.

The **Adult Care Clinic** in both the Lebanon and Franklin offices provides basic physician services and work physicals for clients from 21 years of age to 65 years of age who reside in Warren County. This clinic was developed to provide health care and referral services to uninsured clients or clients with Medicaid. The staff consists of a physician, R.N.s, a secretary, case worker, and a licensed dietician. The case worker helps clients apply for free medications through the patient assistance program of the pharmaceutical companies.

The **Sexually Transmitted Infection Clinic** at the Lebanon office is offered to both men and women. All STI testing and treatment is confidential and is free of charge. The Health Department also offers **HIV/AIDS** testing and education through this clinic.

The **Prevent Blindness Clinic** in the Lebanon office provides free vision exams, at local Optometrists, for low income residents. The exams are provided through State funding.

The **Reproductive Health Clinic** at the Lebanon office provides reliable methods of contraception to enable women to plan their pregnancies. This clinic provides pregnancy testing and complete gynecologic physical exams for clients desiring contraception. Reproductive Health services are also provided to males in this clinic. The staff consists of a physician, registered nurses, secretary, case worker and a licensed dietician. The clinic coordinator has implemented preconception education and counseling programs for prepubescent and pubescent children for many schools and other public organizations. This clinic is a provider for the Ohio Department of Health Breast and Cervical Cancer Screening Project in our Lebanon office. Caseworkers assist clients in applying for Medicaid, when applicable.

The main goal of the **TB Chest Clinic** is to eradicate tuberculosis in Warren County through early diagnosis and treatment. Mantoux skin testing and chest x-rays, when required, are available at a minimal charge to Warren County residents. Treatment for tuberculosis and preventive therapy (INH) are also offered by the Warren County Combined Health District at the Lebanon office.

The **Overseas Travel Clinic** provides immunizations and education necessary to travel safely to/from other countries. This service is provided in the Lebanon office.

The **BCMh (Bureau for Children's Medical Handicaps)** program of WCCHD provides case management and service coordination for Warren County families with the children under the age of 21 years who have or potentially have special health care needs. The health department has one BCMH nurse for Warren County.

In addition, the Warren County Combined Health District offers **nutritional counseling, social services and blood pressure checks** to all clinic clients and residents of Warren County. **Free weight management classes** for all ages are held every Monday, 4:00-6:00 pm, in the Lebanon office.

The health department also provides Spanish interpretation services for clients, if necessary.

## HOME HEALTH NURSING/AIDE CARE

Warren County Combined Health District's home health staff is dedicated to serving homebound clients in Warren County. This staff consists of a home health aide (HHA) and an R.N. that makes HHA supervisory visits to the client's home. The purpose of this care is to enable the patient to remain in the home while enjoying the highest possible level of health.

The home health aide component of the Home Health Program continues to provide personal care assistance for the homebound client. This service is beneficial to the residents because it allows the client to remain in their own home and maintain independent living versus moving from their home and staying in dependent living quarters.

Home bound residents are also provided yearly seasonal flu vaccinations in their home by health department nurses.

## IMMUNIZATION PROGRAM

The immunization program continues to be an important focus of the Warren County Combined Health District. Timely immunization of our children leads to the decline of communicable illnesses such as measles, mumps, rubella, diphtheria, polio, tetanus, pertussis, haemophilus influenza, hepatitis B, hepatitis A, meningitis, rotavirus, etc. Every year the health department experiences many changes that occur within the immunization schedules. New immunizations and new combinations of immunizations are added, while other immunizations are deleted. To meet the immunization needs of the county, we offer a weekly walk-in childhood immunization clinic on Tuesday's 8:00-11:00 a.m. in the Lebanon office, as well as daily appointments.

In addition to the many flu vaccination clinics provided at the Warren County Combined Health District, the nursing staff traveled to various Warren County businesses to provide the flu vaccination to as many residents as possible. This year, the health department began giving the flu vaccinations in September.

The Out-of-Country-Traveling Immunization Program was added in 1999. This program has grown tremendously and continues to provide immunizations to Warren County residents who are traveling out of the United States. This service is also available to people who are not residents of Warren County, at an added cost.

Warren County Combined Health District also offers public health vaccines such as Hepatitis A/B, Pre-Exposure Rabies, Pneumococcal, Meningococcal and Varicella vaccinations.

## WIC PROGRAM

WIC,-The Special Supplemental Nutrition Program for **Women, Infants and Children** is intended to reach income-eligible pregnant, postpartum and breastfeeding women, infants and children up to five years of age with a health or nutrition risk. WIC services are set up to address WIC's most important goal: prevention of nutrition-related health problems. WIC provides: 1) Nutrition education and supplemental foods supplying key nutrients; 2) Health screenings and assessments; 3) Breastfeeding education and support; and 4) Referral to prenatal and pediatric health care and other maternal and child health care and human service programs. All of these services help to improve overall health during the most critical growth and developmental years in a child's life – conception to age five. By preventing health problems early in life, WIC helps save health care dollars later.

The WIC program celebrated its 39<sup>th</sup> birthday on January 15<sup>th</sup>, 2012. In 2012, the Warren County WIC Program maintained an average of 1,561 clients per month. Warren County has been on the retail system for fifteen years now with 20 vendors. The quarterly redemption rate for Warren County is \$413,699.00 in coupon sales. Local WIC projects continue to issue the new food packages that began in October 2009. The new food packages added fruits, vegetables, whole grains, lower fat milk for adults and children two years of age and older and baby food fruits and vegetables, instead of juice for infants. The new food coupons consist of milk, juice, cereal, peanut butter, dried or canned beans, whole grains, fruits, vegetables, infant formula, infant cereal and baby food fruits and vegetables. Our Breastfeeding Peer Helper Program, which started in October 2010, continues to offer breastfeeding support and grow steadily in numbers.

## ENVIRONMENTAL HEALTH

The Environmental Health Division works to protect the environment, prevent disease, and protect the health of the community through the enforcement of local and state rules and regulations along with providing consultations regarding environmental health programs and activities. Our public health environmentalists conduct routine inspections of licensed establishments, investigate public health nuisance complaints, and provide education on environmental issues affecting Warren County. The inspections and consultations illustrate the many activities by the staff in 2012. This past year also included revisions to the Warren County Sewage Treatment System Regulation which became effective July 2012 and minor changes to the Ohio Uniform Food Safety Code effective January 1, 2013.

The Warren County Sewage System Treatment Regulation revisions were written to be more user friendly and understandable. Also, the installation requirements for new and altered sewage treatment systems were revised. Late in 2012, the Ohio Department of Health introduced statewide sewage treatment system regulations which would be enforced statewide, however still administered and conducted at the local level. These rules are not anticipated to be adopted and in place until the end of 2013.

The most significant change in the food safety rules and regulations involved the safe handling of cut leafy greens and other food. This was in response to several nationwide outbreaks involving pre-packaged salad/greens.

In 2012, the environmental health staff continued to inspect all public swimming pools and spas in Warren County at least once a month. As an improvement to the inspection process routine inspections, for the first time, were conducted electronically by the sanitarians on their laptops in the field and then emailed to either the respective pool management company or operator. This procedure provided better overall inspection efficiency.

In the fall, the Ohio Department of Health began developing a statewide electronic inspection program for the environmental health mandated programs. All health districts within Ohio will be able to utilize the same system to issue licenses and conduct inspections. The first three programs to be implemented include food safety, public swimming pools/spas, and camps. The Warren County Environmental Health staff is scheduled to be a pilot site for the new system in 2013.

## **PLUMBING INSPECTION SERVICE**

The Plumbing Inspection Department of the Warren County Combined Health District is responsible for ensuring proper installation of plumbing throughout all of Warren County in accordance with Chapter 4101:2-56-69 of the Ohio Administrative Code, also known as the Ohio Plumbing Code, and local regulations. The inspectors conduct inspections for bathroom and kitchen remodeling (when fixtures are added or moved) water heater replacement, water softeners, new single and multi-family residential, and all commercial plumbing installations. They also review plumbing plans for compliance with the Ohio Plumbing Code and if approved, issue permits. This department also performs inspections of water line installations from the meter pit into the house or building within the City of Mason.

In 2012, 325 plumbing contractors registered with the Warren County Health Department along with 204 installers to do plumbing work. Also during 2012, over 1900 permits were issued, 4689 inspections were made. Over 3200 consultations took place to assist contractors and homeowners.

The Plumbing Inspection Division also administers a water backflow prevention program, which involves making sure building owners have their required backflow prevention device tested annually (as required by the Ohio Plumbing Code) to assure it is working properly to protect the public's drinking water.

## **HEALTH EDUCATION**

Health education activities are an essential part of the health department's mission to improve the health of the residents of Warren County. The health educator continues to work with local agencies, community partners, and residents to help enhance the health of our community.

In 2012, the health educator coordinated and supported the efforts of the Warren County Combined Health District by providing educational information at health/safety fairs, creating brochures, media releases, and flyers for the health department, publishing the Warren County Combined Health Districts monthly newsletter, providing CPR and other training for health department staff and delivering health education presentations to community groups and schools. The health educator also provided support to the bioterrorism program and the Warren County Unit of the Medical Reserve Corps volunteer group, as well as assisted individuals in finding affordable dental and healthcare services. In partnership with the Ohio Department of Health/SIDS Network of Ohio program, the health educator provided agency referrals and support to families who have experienced the unexpected loss of an infant. In addition to these activities, the health educator was also a member of the Warren County Safe Communities Coalition.

## **EMERGENCY PREPAREDNESS AND RESPONSE**

One of the primary roles of the Warren County Combined Health District is to provide a well prepared and effective response to any and all public health emergencies. Whether the scenario is a naturally occurring pandemic flu, like the world saw with Influenza A (H1N1) in 2009, or an act of bioterrorism, we are continually preparing and modifying our emergency response plans to be fully capable of addressing the needs of the growing population in Warren County. This is accomplished by regularly testing emergency response capabilities through local and regional exercises and training health department staff on various components of emergency preparedness and response.

In 2012, the health department made great strides in improving existing plans and strengthening relationships with our local and regional partners. Throughout the year, the Emergency Preparedness and Response Coordinator worked on a complete revision and update of the Warren County Combined Health District Mass Dispensing Plan. This plan outlines multiple aspects of Warren County's procedures to provide medical countermeasures to the public in the event of an acute public health emergency. As required by the Cities Readiness Initiative grant, the Ohio Department of Health conducted an annual Technical Assistance Review of the Warren County Combined Health District in May of 2012, which measured the capacity of our jurisdiction to receive and distribute Strategic National Stockpile medical assets in the event of a public health emergency. Warren County received a score of 84, which was up 9 points from the previous assessment score in 2011.

## VITAL STATISTICS 2012

852 deaths and 7 births were reported and filed as having occurred in Warren County in 2012 (compared to 801 deaths and 12 births in 2011). Births and deaths are recorded in the county in which they occur, regardless of residence. 3,792 certified copies of death certificates, and 1,792 certified copies of birth certificates were issued, along with 279 burial permits, and 57 affidavits for birth and death certificates. Also, 4 certificates of service and 74 supplementary certificates were recorded. In January 2011, the health department began issuing birth abstracts to anyone born in Ohio which is very convenient for residents of Warren County.
