Water Pollution Control Loan Funding Project Accepted for 3833 Anthony Lane, Franklin (motion #107-2018)

Other Business

- ~Mr. Stansbury informed Board members that our Epidemiologist has received notification of a Warren County resident having Acute Flaccid Myelitis (AFM). AFM has been in the news a lot lately. Ohio now has three cases. A fact sheet about the condition was shared with Board members.
- ~The health commissioner also shared information with Board members in reference to E-cigarettes and the increase in use by the teen population. According to the 2018 National Youth Tobacco Survey, the number of teens using e-cigarettes has rose 78% in the last year. The FDA has recently taken action to require age verification safeguards as well as banning flavors and menthol in many products. The flavored products are a major reason teens begin using the products in the first place.
- ~We did not receive renewal of the Sleep Safe grant this year. There were other counties with higher rate of infant mortality who did receive the grant. Mr. Stansbury and Mrs. Smyth made it clear that we would still promote safe sleep and also provide cribs when a family is in need.

With no further business to discuss the Board dismissed at 7:14 pm.
