MINUTES OF April 16, 2019 WARREN COUNTY BOARD OF HEALTH MEETING

The regular monthly meeting of the Warren County Board of Health was held Tuesday April 16, 2019 in the first floor conference room of the Warren County Health District, 416 South East Street, Lebanon, Ohio. President, Mr. Dick Staten, called the meeting to order at 6:00 pm.

Board of Health Educational Session (6:00 to 6:25 pm)

Dianna Glenn, TB/Disease Coordinator/Interim Director of Nursing gave the Board of Health members a presentation on the ABC's List of Communicable Diseases. Mrs. Glenn reviewed a list of reportable diseases and talked about the timeline for reporting based on the severity of the disease. She told them she reports to the State and the State reports to the Center for Disease Control. She also shared with them what her job entails as far as tracking and methodologies involved in investigating reportable diseases to help identify origination and/or sources of the disease.

Financial Review To Date

There were no questions in reference to the financial statement. Mr. Stansbury told Board members the staff has been doing very well being fiscally responsible. He explained that he had recently met with the County Auditor who advised him, in regards to the levy, a renewal is better for the taxpayer because a renewal will use old appraisal rates (from last levy 10 years ago) whereas a replacement would use the latest appraisal rates.

Administrative Report

Mr. Staten turned the meeting over to the Health Commissioner for his Administrative Report items.

Voted to Approve Resolution #19-03 to Certify Need for Levy Renewal (motion #38-2019)

Resolution #19-03 certifies to the County Commissioners the need for the health district to place a ten year 0.5 mill renewal levy on the fall ballot. The present health levy expires in 2020. Dr. Barr made a motion to approve Resolution #19-03 and Mr. McClanahan seconded the motion. The following is a result of a roll call vote:

Approved Amendment #1 to Contract Services Agreement, with Viox Excavating, for the Approved Water Pollution Control Loan Fund project at 3833 Anthony Lane (motion #40-2019)

The homeowner at 3833 Anthony Lane has provided updated 2018 income verification and tax information and now qualifies for a different coverage tier through the Ohio EPA's Water Pollution Control Loan Fund. Amendment #1 was presented to Board members for their approval. Water Pollution Control Loan Funding - 10930 Ross Road (motion #41-2019)

The system designer, serving as the agent for the owner, of the property at 2442 Berkeley Court (Clearcreek Township) has asked for a variance from Ohio Administrative Code 37101-29-15 (O)(3) which indicates minimum required length and separation between zones. The applicant states the minimum separations will not be able to be met but they will install additional interceptor drain between the soil absorption components to support lesser separation. On recommendation from the Environmental Health Director, Dr. Barr made a motion to approve Variance Request #3-2019 and Mr. McClanahan seconded the motion.
