# MINUTES OF September 17, 2019 WARREN COUNTY BOARD OF HEALTH MEETING

The regular monthly meeting of the Warren County Board of Health was held Tuesday September 17, 2019 in the first floor conference room of the Warren County Health District, 416 South East Street, Lebanon, Ohio. President, Mr. Dick Staten, called the meeting to order at 6:08 pm.

#### Board of Health Educational Session; An Accreditation Process Update

#### Application Approved for Water Pollution Control Loan Funding (motion #90-2019)

The Environmental Health Division received an application for funding through the 2018 and 2019 Water Pollution Control Loan Fund (WPCLF) through Ohio EPA for soil evaluation, design and installation of a sewage treatment system at 2789 N. State Route 48, Lebanon. The applicants have provided sufficient tax information to verify that they are eligible for the funding program. Ms. Boyd made a motion to approve the application be accepted into the WPCLF program. Mr. McClanahan provided a second and the following is a response to a roll call vote:

Bid Selected for Water Pollution Control Loan Funding Project at 7256 Shaker Road (motion #91-2019) Board members were provided with two bids to install a proposed sewage treatment system at 7256 Shaker Road. The homeowners will be covered 85% through the WPCLF program. Dr. Barr made a motion to accept the bid submitted, from SepTek Services, in the amount of \$17,900.00 for the completion of the work. Mrs. Zajo provided a second to his motion and the following is a result of a roll call vote:

# <u>Bid Selected for Water Pollution Control Loan Funding Project at 8650 Red Lion Five Points Road</u> (motion #92-2019)

Board members were provided with only one bid received to install a proposed sewage treatment system at 8650 Red Lion Five Points Road. The homeowners will be covered 100% through the WPCLF program. Dr. Barr made a motion to accept the bid submitted, from SepTek Services, in the amount of \$34,000 for the completion of the work. Mrs. Zajo provided a second to his motion and the following is a result of a roll call vote:

- ~ Mr. Stansbury shared literature on Vaping with Board members. Vaping continues to be a huge public health problem. He said our health educators are working with the schools who are asking how to educate their staff and students.
- ~ The health commissioner informed that Governor Mike DeWine signed a change into law under a provision in the new state budget increasing the legal age, from 18 to 21, to buy cigarettes and other tobacco products in Ohio. The change goes into effect October 17, 2019.
- ~ Board members were informed the health districts PHAB (Public Health Accreditation Board) site visit is coming up on October 8<sup>th</sup> and 9<sup>th</sup>, 2019. The portion of the site visit where the PHAB team would like to meet with some of the Board members is 10/9/19 at 10:30 am. Dr. Barr and Ms. Boyd will be present for sure. Others are checking their schedule.
