Interact for Health's Evidenced-Based Tobacco Policy Change Grant

The health commissioner informed the Board of Health that Tobacco Prevention Health Educator, Amy Fehrenbach, recently submitted a RFP application for an evidenced based tobacco policy grant. He said the focus of the grant is tobacco retailer license policy development.

Early Childhood Safety Initiative - Cribs for Kids Safe Sleep Program

The Cribs for Kids Sleep Program is an initiative the health district has been doing for several years and even continued when the funding was no longer available a couple years ago. Mr. Stansbury shared with the Board attachments to the Grant Activities Statement of Work for the period January 1, 2020 through June 30, 2020 which includes a funding breakdown for salary/fringe and also program materials/supplies. He told Board members will again be receiving some funding for this Early Childhood Safety Initiative.

Board Informed of Administrative Hearing for Clarksville Road (Washington Township)

The environmental health division has been working, with no luck, to contact next of kin of an owner who has passed away to have the property at 166 S. Clarksville Road, which was damaged by fire, secured. After consulting with the Warren County Prosecutor's Office notifications will be sent to the next of kin of an administrative hearing to be held during the January, 2020 Board of Health meeting. Mr. Adam Nice of the Prosecutor's office will be present to assist the board with the administrative hearing process.
