# MINUTES OF March 21, 2023 WARREN COUNTY BOARD OF HEALTH MEETING

The regular monthly meeting of the Warren County Board of Health was held Tuesday March 21, 2023 in the first-floor conference room of the Warren County Health District, 416 South East Street, Lebanon, Ohio. President, Mr. Dick Staten called the meeting to order at 6:00 pm.

### **Introduction of new Board Member**

### **Board of Health Educational Session**

They also have a Mobile Response and Stabilization Service, for youth support, she spoke about.

## **Approved Allocating Funds for Tire Recycling Events** (motion 40-2023)

The Environmental Health Division has two upcoming tire events scheduled. As in previous years, it is hard to gauge exactly how many tires will be brought in for each event. Tara Thornton, Environmental Health Director requested additional funds be approved to pay for the events if the expenses associated exceed what Mosquito Control Grant will cover. Dr. Barr made a motion to allocate \$10,000 to be used for 2023 tire recycling events, if needed. Mr. Brigano provided a second and the following is the response of a roll call vote:

Dianna Glenn, of Nursing informed Board members of a recent Meningococcal disease in Warren County resident. Duane said Dr. Koles, Dianna, and the nursing staff did a very good job handling this from the media releases to getting 56 people who were identified as contacts treated with antibiotic.

Chris Balster informed Board members of a recent employee incentive survey that was conducted to gauge insight as to what employees would be interested in having incorporated to our benefits, policies, etc. He reported the top 3 incentive from the survey were; reduced work week, e.g. 4 day work week; hybrid schedules with remote work; and additional financial compensation outside of hourly rate. After sharing the results of the survey, the Board said the members on the Personnel Committee will meet at 5 pm next month, prior to Board meeting, to review it closer. They thanked Duane and Chris for the information.
